

AVIVA PRIZE DRAW – IRELAND V SOUTH AFRICA RUGBY TRIP (“the Prize Draw”)

TERMS AND CONDITIONS

These terms and conditions apply to the Aviva Prize Draw to win tickets to the Ireland v South Africa Rugby game at the Aviva Stadium in Dublin, Ireland, with flights from the UK and accommodation included (the “Event”). By choosing to enter this Prize Draw you are accepting these terms and conditions, so please read them carefully before deciding whether to take part.

1. The Prize Draw

1.1 We have two pairs of tickets to attend the Event on Saturday 22nd November 2025 at 5.40pm ([click here](#) for further details of the Event). Each of the two winners of the Prize Draw will receive a pair of standard tickets to the Event, two standard flights to Dublin from a UK airport with regular, scheduled flights to Dublin on Saturday 22nd November and a return flight back from Dublin to the UK airport of departure on Sunday 23rd November together with one nights’ accommodation on the night of the Event in a twin room at a hotel in Dublin pre-booked by Aviva. Entry to the Prize Draw is free and no purchase is necessary.

1.2 You must have received an email invitation addressed to you from Aviva in order to enter the Prize Draw. After receiving your email invitation there are four ways you can enter, simply follow the steps applicable to your situation as follows:

(a) Already Registered for MyAviva?

(i) If you have registered for MyAviva but do not have the MyAviva App just:

Download the MyAviva App from your chosen app store and then login to it before midnight on Sunday **28th September** (the “**Closing Date**”) and you will be automatically entered into the Prize Draw; or

(ii) If you have already registered for MyAviva and have the MyAviva App: Login via either the MyAviva App or the MyAviva website portal before midnight on **Sunday 28th September** (the “**Closing Date**”) and you will be automatically entered into the Prize Draw; or

(b) If you have not already registered for MyAviva?

Register for MyAviva, and login via either the MyAviva App or the MyAviva website portal before midnight on **Sunday 28th September** (the “**Closing Date**”) and you will be entered into the Prize Draw automatically.

1.3 The prize tickets are subject to any applicable Irish Rugby Football Union (IRFU) rules relating to the tickets and those of the Aviva Stadium.

1.4 The prize comprises of the tickets, flights to and from Dublin and one nights’ accommodation only and the winner is responsible for, and cannot claim for any additional travel, accommodation, subsistence, or other costs and expenses they may incur to attend the Event. The winner is also responsible for ensuring they are

available to attend the Event and for making any arrangements to do so. Aviva will book the flights and hotel on their behalf.

- 1.5 The prize is for the two named winners only and one guest per winner and cannot be sold on.
- 1.6 The prize is non-exchangeable and there is no cash alternative, and it may not be transferred for value. If necessary, due to circumstances beyond our control, Aviva reserve the right to substitute a cash alternative for the prize or offer an alternative prize of the same monetary value, without prior notice.

2. Eligibility to take Part

- 2.1 Each entrant is only eligible to win one prize of a pair of tickets and you have to have a MyAviva account and to have received an invitation by email to enter. Only one entry will count, if you provide your details more than once, you will only be entered in the Prize Draw once. You must also be over 18 years of age and a UK resident with a permanent UK address at the time of entry. Employees of Aviva group companies in the UK are not eligible to enter the Prize Draw.
- 2.2 Our decision regarding any aspect of the Prize Draw is final and binding and no correspondence will be entered into about it.

3. Selection of the Winners and receipt of the Prize

- 3.1 Aviva will select the winners by electronic random selection from the eligible entries. If you are one of the winners, you will receive an email from corporatehospitality@aviva.com informing you during the week commencing **Monday 6th October 2025**. If you have any accessibility requirements, please advise us at this point. The prize tickets will then be sent to you via email by corporatehospitality@aviva.com. You will also be contacted by, an Aviva representative, to book your flights and accommodation.
- 3.2 Once you have been contacted by corporatehospitality@aviva.com to confirm you have been selected as a winner, you will have five working days to confirm whether you can or cannot attend. If we do not receive a response, you will be disqualified as a winner and another winner will be selected from the pool of entrants using random electronic selection.
- 3.3 For any winners, should you no longer be able to attend the Event, please notify corporatehospitality@aviva.com by email in advance and Aviva will cancel your tickets.

4. Use of Personal Information and the Names of Winners

- 4.1 Any personal data provided by you to enter this Prize Draw will only be used to administer the draw in accordance with these terms and conditions, to notify the winners and to provide you with your prize if you are one of the winners.

5 The Promotor

- 5.1 The promotor of this Prize Draw is Aviva Digital UK Limited a company registered in England & Wales with registered number 09766150 and whose registered office is at 8 Surrey Street, Norwich, Norfolk NR13RG (“**Aviva**”, “**we**”, “**us**” or “**our**”). Aviva Digital UK Limited sells insurance provided and underwritten by Aviva Insurance Limited a company registered in Scotland, No SC002116 with its registered office at Pitheavlis, Perth, PH2 0NH (company number 202153).
- 5.2 This Prize Draw is separate from the Event and is administered and operated by Aviva, not the IRFU.

6. General

- 6.1 Aviva will not be liable to compensate you if: your prize is lost, stolen, unused, destroyed or used without permission, unless caused by Aviva's negligence.
- 6.2 While nothing in these terms and conditions will limit Aviva's liability for death or personal injury caused by its negligence or for fraud, or any other liability which cannot be lawfully excluded or limited, Aviva shall not be liable for:
- any failure to comply with its obligations where the failure is caused by something outside its reasonable control; or
 - for any losses that that you may incur which were not foreseeable by Aviva or you at the time of your participation in the Prize Draw.
- 6.3 If there is any reason to believe that there has been a breach of these terms and conditions, we may, at our sole discretion, reserve the right to exclude you from participating in the Prize Draw.
- 6.4 If any paragraph in these terms and conditions is found by any court or administrative body of competent jurisdiction to be invalid or unenforceable, such invalidity or unenforceability shall not affect the other paragraphs of these terms and conditions, which shall remain in full force and effect.
- 6.5 These terms and conditions are subject to the laws of England and Wales and disputes will be subject to the non-exclusive jurisdiction of the English courts.
