IRELAND V SOUTH AFRICA RUGBY TRIP

TERMS AND CONDITIONS

These terms and conditions apply to the Aviva Signature Prize Draw (the “**Prize Draw**”) to win tickets to see Ireland and South Africa in the 2026 Nations Championship at the Aviva Stadium in Dublin, Ireland, with flights from the UK and overnight accommodation included (the “**Event**”). If you choose to enter this Prize Draw you are accepting these terms and conditions, so please read them carefully before deciding whether to take part.

1. The Prize Draw and how to enter

- 1.1 We have TWO pairs of tickets to win for the Event at the Aviva Stadium in Dublin on 21 November 2026 at 16:40 – [click here for details of the event](#). There will be two winners, each of whom will receive one pair of tickets. No entrant may win more than one prize. Winners will also receive two economy-class flights to Dublin from a UK airport with regular, scheduled flights to Dublin on Saturday 21st November 2026 and a return flight back from Dublin to the UK airport of departure on Sunday 22nd November 2026, together with overnight accommodation in Dublin for the night of the Event. Please note you must be over 18 to enter the Prize Draw and all attendees at the Event must be 18 years old or over. Entry to the Prize Draw is free and no purchase is necessary.
- 1.2 Entrance to the Prize Draw is limited to selected Aviva Signature Home and Motor Insurance customers, who receive an email inviting them to enter. The invitation is for the named email addressee only, who will be the main policy holder. If you receive an email invitation, please complete the linked web form by no later than 11:59pm (GMT) on Wednesday 30th September (the “**Closing Date**”) and you will automatically be entered into the Prize Draw. You may only enter once. Employees of Aviva group companies in the UK are not eligible to enter the Prize Draw unless you hold an Aviva Signature Motor or Home Insurance policy. Members of the Aviva Signature Club Working Group are not eligible to enter.
- 1.3 Each prize consists of two standard tickets to the Event, one hotel room for the night of the Event, and two return economy-class flights to and from Dublin, all of which will be arranged and booked by Aviva. You are responsible for, and cannot claim reimbursement for, any additional travel expenses, subsistence, or other costs you may incur in attending the Event. You are also responsible for ensuring that you are available to attend the Event and for making any arrangements necessary to do so.
- 1.4 The prize tickets are for the named winners only and one guest and cannot be sold on.
- 1.5 The prize tickets are subject to any applicable Irish Rugby Football Union (IRFU) rules relating to the tickets and those of the Aviva Stadium.
- 1.6 The prize is non-exchangeable and there is no cash alternative, and it may not be re-gifted or transferred for value. If necessary due to circumstances beyond our control, Aviva reserve the right to substitute a cash alternative for the prize or offer an alternative prize of the same monetary value, without prior notice.
- 1.7 Our decision regarding any aspect of the Prize Draw is final and binding and no correspondence will be entered into about it.

2. Selection of the Winners and receipt of the Prize

- 2.1 The draw will take place the week commencing the 5th October and Aviva will select the winners by electronic random selection from the eligible entries. If you are the winner, we will email you using corporatehospitality@aviva.com within one working day of the draw notifying you that you are the winner and requesting your preferred contact details for making arrangements for receipt of your prize and confirming if you or your guest have any accessibility requirements. You will not be notified if you have not won but please check your “junk” email folder to ensure that your computer has not moved the winning notification email out of your main email folder. If we do not hear back from you within three days of sending the winning email notification, or if you are unable to attend the Event for any reason (tickets cannot be re-gifted), unfortunately your prize will be void and we will select an alternative winner using random selection from the remaining eligible entries, adopting the same process if required.
- 2.2 If you subsequently are unable to attend the Event, after initially confirming you will be, please notify corporatehospitality@aviva.com as soon as possible by email and Aviva will choose another winner save where there is not sufficient time left before the Event to enable an alternative winner to attend. Unfortunately, you cannot elect for anyone else to attend in your place as the prize cannot be re-gifted or sold on.

3. Use of Personal Information and the name of the Winners

- 3.1 Aviva are the data controller of any personal data processed in connection with this Prize Draw and our lawful basis for doing so is our legitimate interest in offering promotional incentives to customers. We use entrants personal data to administer the Prize Draw in accordance with these terms and conditions, and to notify the winners and organise the receipt of their prize.

- 3.4 Please note that if you are a winner, third party privacy policies may apply at the Event and audio-visual footage and images may be taken featuring spectators.

4 The Promoter

- 4.1 The promoter of this Prize Draw is Aviva Digital UK Limited a company registered in England & Wales with registered number 09766150 and whose registered office is at 8 Surrey Street, Norwich, Norfolk NR1 3NG (“**Aviva**”, “**we**”, “**us**” or “**our**”). Aviva Digital UK Limited sells insurance provided and underwritten by Aviva Insurance Limited a company registered in Scotland, No SC002116 with its registered office at Pitheavlis, Perth, PH2 0NH (company number 202153).
- 4.2 This Prize Draw is separate from the Event and is administered and operated by Aviva.

5. General

- 5.1 Aviva will not be liable to compensate you if: your prize is lost, stolen, unused, destroyed or used without permission, unless caused by Aviva's negligence.
- 5.2 While nothing in these terms and conditions will limit Aviva's liability for death or personal injury caused by its negligence or for fraud, or any other liability which cannot be lawfully excluded or limited, Aviva shall not be liable for:
- any failure to comply with its obligations where the failure is caused by something outside its reasonable control; or
 - for any losses that you may incur which were not foreseeable by Aviva or you at the time of your entry to the Prize Draw.
- 5.3 If there is any reason to believe that there has been a breach of these terms and conditions, we reserve the right to exclude you from participating in the Prize Draw.
- 5.4 If any paragraph in these terms and conditions is found by any court or administrative body of competent jurisdiction to be invalid or unenforceable, such invalidity or unenforceability shall not affect the other paragraphs of these terms and conditions, which shall remain in full force and effect.
- 5.5 These terms and conditions are subject to the laws of England and Wales and disputes will be subject to the non-exclusive jurisdiction of the English courts.
