Living with your grown-up kids can be wonderful, but it helps to set expectations from the start.

Use our contract template to help define how you can live together as adults, or simply as a guide of things to talk about in advance.

1 Duration

How long will the Agreement last?

1.1 This Agreement starts on

2 Rent / Savings

Will your child be paying rent, concentrating on saving, or both?

3 Bills

What household bills will your child contribute to and how much?

3.2 If your child will pay a fixed sum towards the Monthly Household Bills:

4 Home Upkeep

Will your child be expected to help out with any household tasks? E.g. vacuuming, dish washing, mowing the lawn. Consider how often these tasks need to be performed.

4.1 You will assist around the home by performing the below tasks and will assist with other tasks as reasonably requested by us.

4.2 You will be solely responsible for the clean and tidy keeping of

5 Use of Car

Will your child have shared use of your car? Consider any conditions to such use, e.g. let you know before using, regularly refuel the car, pay for damage and fines.

5.1 You may use our car as necessary provided you

(list conditions to use, e.g. let us know before you use the car / regularly refuel the car and do not return it to us with an empty or nearly empty fuel tank).

5.2 You must report any damage to the car or any concerns with the car's operation to us so that we can arrange maintenance and/or repair.

5.3 You will be solely responsible for: (i) any damage to the car caused by your negligent use or operation, and (ii) any financial penalty you incur while using the car (e.g. parking tickets, speeding fines).

6 **Guests, Alcohol and Drugs**

Are you happy for your child to have guests at the home? Can those guests stay overnight?
Are you happy for he/she to host gatherings or parties at your home?

- 6.1** You may have guests at the home but you must: (i) inform us in advance if any guests are to stay overnight, and (ii) get our advance permission to host gatherings/parties of (number) or more people.
- 6.2** We may refuse to allow certain people to be at our home and you must abide by this decision.
- 6.3** You may store and consume alcohol at the house
- 6.4** You must not store or ingest illegal drugs at the house.

7 **Miscellaneous**

Are there any other matters that will be relevant to your child's return to the home?
Consider whether agreement should be reached on those matters in advance
in order to avoid conflict later, e.g. home safety, storage of their belongings.
