Aviva Multi-Car Offer

Terms and Conditions

Offer Description

1. This offer ("Offer") is provided by Aviva Direct Ireland Limited ("Aviva"). If a customer, together with other members of their household (collectively and separately referred to as "you" and "your" as appropriate) buys or renews more than one motor insurance policy with Aviva, we will give you 10% off each Eligible Policy up to a maximum of 5 Eligible Policies ("Aviva Multi Car Discount").
2. "Anchor Policy" means a motor insurance policy purchased by you from Aviva that does not have the Aviva Multi Car Discount applied. "Eligible Policy" means each motor insurance policy purchased by you from Aviva other than your Anchor Policy.
3. To be eligible for the Offer, you must be a new or existing Aviva car insurance customer with a start date or a renewal date for your Eligible Policies which is on or after 1st October 2017. Your Anchor Policy and Eligible Policies must be issued to the same postal address.
4. The Offer applies to customers who purchase their policies directly from Aviva and does not apply to broker or other intermediary customers.
5. The Offer is subject to a minimum premium of €310 for each Eligible Policy.
6. This offer is not a product offering, but a discount associated with Aviva's current 'Motorcare' product.
7. Where one or more Eligible Policy is cancelled by you and only one remaining Aviva motor insurance policy is held by you, the Offer will no longer be applicable to that existing policy.

8. In order to avail of the Aviva Multi Car Discount as a new Aviva customer, you must (i) provide your Anchor Policy number when generating a motor insurance quote online at Aviva.ie or (ii) provide your Anchor Policy number when speaking with Aviva's agents on 1800 333 322.
9. In order to avail of the Aviva Multi Car Discount upon renewal of your Aviva motor insurance policy, you must contact Aviva at 1800 333 322 and provide your Anchor Policy number before you renew your Aviva motor insurance policy.
10. The Aviva Multi Car Discount will be applied to your premium on the next renewal or start date of each Eligible Policy after 1st October 2017.
11. The Aviva Multi Car Discount details will be set out in the premium breakdown of your renewal notification ("How we calculate your premium"). If the Aviva Multi Car Discount is not detailed in your renewal documentation, please call us on 1800 333 322.
12. The Aviva Multi Car Discount is not applicable to Mid-Term Adjustments, and will not be recalculated until the next renewal date.
13. The terms and conditions of the this Offer are governed by Irish law and any dispute arising out of or in connection with this offer shall be dealt with exclusively by the Irish Courts.
14. You are deemed to have accepted these terms and conditions by participating in the Offer.
