

Aviva Save Fixed Term Savings Account Promotion

Terms & Conditions

These Terms and Conditions apply to the Aviva Save Fixed Term Savings Account Promotion (the “**Promotion**”). By taking part and claiming an e-Gift Card (“**e-Gift Card**”) under this Promotion, you are accepting these Terms and Conditions.

1 The Promotion Period and the minimum deposit required

a We are running a promotion where new Aviva Save customers can claim an e-Gift Card worth between £20 and £150 from a choice of Amazon.co.uk Gift Card*, B&Q and Sainsbury's. Subject to the eligibility requirements in Section 2, an e-Gift Card will be offered to new customers who:

- i** Join the Aviva Save Platform by opening a new Aviva Save account;
- ii** Apply for and open one or more Fixed Term Savings Account(s), each with a minimum term of at least 9 (nine) months, from the selection available on the Aviva Save Platform (“**Fixed Term Savings Account(s)**”); and
- iii** Successfully deposit £10,000 (ten thousand pounds) or more via one or more transactions into their new Fixed Term Savings Account(s) (deposits may be made into one new account or spread across all the new Fixed Term Savings Accounts opened),

With all these actions being completed between 12:00pm (midday) on Monday 5th January 2026 and 12:00pm on Friday 13th February 2026 (the “**Promotion Period**”).

b The value of the e-Gift card you receive is dependent on the amount you deposit in your Fixed Term Savings Account(s) calculated in accordance with the tiered table in Section 3 with the minimum required deposit being £10,000. The e-Gift Card will be delivered electronically. For information on how to select the type of e-Gift Card you want from the three choices of retailer and how to claim it, please see Section 4 below.

c Please note that if you intend to deposit more than £120,000, you must open a second Fixed Term Savings Account with a different banking group, from the selection on Aviva Save so as to ensure you are still protected by the FSCS deposit protection scheme for both accounts.

d Please be aware that any money that you deposit in Fixed Term Savings Account(s) cannot be withdrawn until the applicable term for the product has elapsed, (details of this term, which varies between products, will be available at the time you take out the applicable account).

2 Eligibility

The following criteria also apply to the Promotion:

- You must be resident in the UK, and aged 18 or over. Access to Aviva Save also requires you to have a MyAviva account so you will need to open one if you don't currently have one.
- You must be a new Aviva Save customer who has not registered for an Aviva Save account prior to the Promotion Period. Customers who have an existing Aviva Save account from prior to the Promotion Period who take the actions in Section 1 during the Promotion Period are not eligible for this Promotion (even if this is their first Fixed Term Savings Account application using the Aviva Save Platform).
- Sums which are still within your Aviva Save transaction account, but not successfully transferred into one of your Fixed Term Savings Account(s) during the Promotion Period, do not count.
- This Promotion cannot be used in conjunction with any other offer.

3 Your e-Gift Card

a The value of the e-Gift Card offered will be calculated based on the total deposit(s) you make into your Fixed Term Savings Account(s) in accordance with these terms and conditions as follows:

Between £30,000-£39,999	£40
Between £40,000-£59,999	£50
Between £60,000-£79,999	£75

b e-Gift Cards are limited to one per customer under the Promotion and once you have made your selection of preferred gift card retailer as between Amazon.co.uk Gift Card*, B&Q and Sainsbury's in accordance with Section 4 you cannot change it.

c Your use of the e-Gift Card will also be subject to any retailer specific terms applying to the type of e-Gift Card you choose (these terms will be available at the point of e-Gift Card selection).

d The e-Gift Cards have retailer determined expiry dates by when they must be used, please refer to the retailer specific terms for details at the time of choosing.

e e-Gift Cards are non-transferable, non-exchangeable and will not be substituted by Aviva for an equivalent cash value. Aviva reserves the right to replace your e-Gift Card with a similar substitute of equal or greater value.

4 How to claim your e-gift card

a If you are eligible, you will be sent an email inviting you to claim your e-gift card within 30 days after the end of the offer period.

b You have a further 30 days to claim your e-Gift Card online. Please ensure you claim your e-Gift Card during this time as failure to do so will mean your entitlement an e-Gift Card will be forfeited. The e-Gift Card is made available to claim on-line, via a link you will be sent. You can choose between an e-Gift card from Amazon.co.uk Gift Card*, B&Q and Sainsbury's. Once you have chosen your e-Gift Card please allow up to 28 working days for it to be received.

c If you believe you are eligible and have not received an email inviting you to claim your e-Gift Card by 15 March 2026 please contact us. For all other issues relating to the e-Gift Card please contact MLP, our administrator of the Promotion, using the contact details in the email you receive.

5 Data Protection

a Aviva is the controller of any personal data it collects from you in connection with the Promotion. Aviva's lawful basis for processing the personal data will be its legitimate interests in offering this Promotion. Aviva will share your name, email address, and other unique identifiers with MLP to enable them to administer the Promotion on our behalf. MLP is only permitted to use your personal data for this purpose. Note when using your e-Gift card your personal data will be subject to the privacy policy of the applicable retailer you selected.
