

Aviva Fusion promotion: ten percent discount on quotations for new Aviva Group Income Protection policies (the “Promotion”)

1. The Promotion and how to Participate

- 1.1 We are offering Aviva Advisers using Aviva Fusion the opportunity to obtain a 10% (ten percent) discount on quotations for new Aviva Group Income Protection Policies (3-250 lives). The discount applies to quotations for the inception of new policies with Aviva for the duration of the initial rate guarantee period. Rate reviews and renewals of policies which were taken out prior to the Promotion Period are specifically excluded from the Promotion. The Promotion is available for quotations between 1 February 2026 to the 30 May 2026 (inclusive) (the “Promotion Period”).
- 1.2 To take advantage of this Promotion all you need to do is:
 - sign up to the Aviva Fusion Quote Platform on Connect (if you have not done so already);
 - request a client quotation using Aviva Fusion during the Promotion Period,and the ten percent discount, where applicable, will be automatically deducted from the total premium quoted on Aviva Fusion.
- 1.3 After receipt of a discounted quotation, it will remain valid for a period of 90 days from the date of issuance for your client to accept and purchase the Group Income Protection policy at the discounted rate. You can make as many quotation requests as you like during the Promotion Period.
- 1.4 The Promotion only applies to quotations obtained during the Promotion Period, but the validity period for acceptance of 90 days will still apply to the quotation even if the validity period extends beyond the end of the Promotion Period.
- 1.5 Quotations must be completed online using the Aviva Fusion Platform and not by other methods to be eligible for the Promotion.
- 1.6 The discount your customer receives will be applied according to whether the premium is paid annually, quarterly, or monthly with the premium discount applied pro-rata to each payment where the premium is paid other than by a single annual advance payment.
- 1.7 This Promotion may not be used in conjunction with any other Aviva offers in relation to Aviva Group Income Protection products. The Promotion does not apply to advisers located in the Isle of Man or the Channel Islands.

1.8 This Promotion only affects the premium quotation you are offered, all other terms and conditions applying to the Aviva Group Income Protection product and you as an adviser remain unchanged.
