

Aviva Life Insurance Plan Gift Card Promotion

- 1 These terms and conditions apply to the Aviva Life Insurance Plan Gift Card Promotion (the “**Promotion**”). Eligible customers can claim an Amazon.co.uk Gift Card* (“**Gift Card**”) worth between £50 and £200 when they purchase a new Aviva Life Insurance Plan. By claiming a Gift Card in connection with this Promotion, you are accepting these terms and conditions, so please read them carefully before deciding whether to participate.
- 2 You are eligible to benefit from this Promotion if you apply for a new Aviva Life Insurance Plan anytime between 12:00am on 18th May 2026 and 11:59pm on 13th July 2026 (the “**Promotion Period**”). You must then go on to purchase that product (whether during or after the Promotion Period) and pay the first six (6) consecutive monthly premiums due for that plan to receive a Gift Card. The value of the Gift Card you receive is calculated based on the monthly premium you pay for your plan (see Paragraph 7). If your application is declined for any reason, you will not be able to participate in the Promotion. You must also be resident in the UK and aged between 18 and 77 at the time you apply. - 3 The Promotion is not available if you apply for an Aviva Life Insurance Plan through any other channel (including through a price comparison/cashback site or via a third party) or if it is purchased with any other gifts or offers. You will not be eligible to benefit from this Promotion if, within the last 24 months, you have already received a gift card on an Aviva Life Insurance Plan or Over 50s Life Insurance product purchased directly from Aviva. You will also not be eligible to benefit from this Promotion if you have cancelled an Aviva Life Insurance Plan or Over 50s Life Insurance product within 12 months of the purchase date. This offer cannot be used by Aviva staff members, or in conjunction with any other discount and offers.
- 4 The Promotion is subject to availability. The Promoter reserves the right to end or modify the Promotion at any time, for any reason and without prior notice or explanation but will always endeavour to minimise the effect on participants to avoid undue disappointment. Termination or modification of the Promotion will not affect eligible customers’ entitlement to a Gift Card if they have applied for an Aviva Life Insurance Plan before the termination or modification date.
- 5 The Promotion is limited to one Gift Card when you purchase an Aviva Life Insurance Plan (including single or joint plans). There is a limit of two Gift Cards per household, and a maximum one per person. For joint policies, the gift card may be issued to either of the named policyholders and is not necessarily allocated to the individual responsible for payment of the policy.
- 6 If you are eligible for a Gift Card, you will receive an email inviting you to claim your Gift Card within 28 working days of receipt by us of your sixth monthly premium payment. Your Gift Card must then be claimed within 45 days of receipt of the email. Gift Cards are valid for ten years from their date of issue. Please note that the Gift Cards are provided electronically, and not as physical gift cards. - 7 The value of the Gift Card will be calculated based on the monthly premium paid for your Aviva Life Insurance Plan in accordance with the table below. If you take out both an Aviva Life Insurance Plan and an Aviva Critical Illness Plan under this Promotion, only the value of your monthly premium for the product promoted will be used for the purposes of calculating the value of your Gift Card.
