

Move with Aviva prize draw

Terms & Conditions

These terms and conditions apply to the #MovewithAviva Strava x Aviva Challenge Prize Draw (the “**Prize Draw**”). By choosing to enter this Prize Draw and/or claiming a Prize, you are accepting these terms and conditions, so please read them carefully before deciding whether to take part.

1 The Prize Draw

1.1 We have the following prizes available in the Prize Draw:

- a** a Wellbeing Escape valued at £5,000;
- b** 10 x £100 Amazon.co.uk Gift Cards; and
- c** 20 x 12-month subscriptions to The Body Coach App; (together, the “Prizes”).

Entry to the Prize Draw is free and no purchase is necessary.

1.2 To enter the Prize Draw, simply:

- a** Sign up or log in to **Strava***;
- b** Complete the #MovewithAviva challenge on Strava by recording 300 minutes of movement on **the challenge page** between 1 April and 30 April 2024. Join the #MovewithAviva challenge [here](#). You can either input your activity manually or log it via connecting your Strava account. You can count any wellbeing activity towards the challenge including walking, jogging, running, yoga, swimming, breathwork, surfing, cycling and more; and
- c** Once you have completed the challenge, submit your name and email address via the Aviva entry page you will see linked on the Strava challenge page before 12.00am on 8 May 2024 (the “**Closing Date**”) and you will be entered into the Prize Draw.

*Aviva has partnered with Strava to host the #MovewithAviva challenge. Your use of Strava is subject to Strava’s **terms and conditions** and **privacy policy**. A paid for Strava subscription is not needed to participate, you can sign up to Strava for free.

1.3 The Prizes comprise of the above items set out in section 1.1 only and you are responsible for, and cannot claim expenses for, any other costs you may incur. Aviva has no responsibility other than providing the Prizes “as is” to the winners. All Prizes are subject to third parties’ terms and conditions (see below section 3).

1.4 The prizes are non-exchangeable and there is no cash alternative, and they may not be transferred for value. If necessary due to circumstances beyond our control, Aviva reserves the right to substitute a cash alternative for the prize or offer an alternative prize of the same monetary value, without prior notice.

2 Eligibility to take part

- 2.1 Each entrant may only enter once and is only eligible to win one Prize. You must also be over 18 years of age and a UK resident with a permanent UK address at the time of entry. **Employees of Aviva companies are not eligible to enter.**
- 2.2 Our decision regarding any aspect of the Prize Draw is final and binding and no correspondence will be entered into about it.

3 Selection of the Winners, Prizes and receipt of the Prize

- 3.1 The draw will take place within five working days of the Closing Date and Aviva will select the winners by electronic random selection. If you are one of the winners, we will email you using the information you provided within one working day of the draw date. Winners will be asked to claim their prize within 14 days by sending their Strava username and a screenshot of their #MovewithAviva digital completion badge to Aviva by reply email. If a winner does not respond to our email and provide the requested information within 14 days, the draw will be void and we will redraw that prize. The prize information will be sent to winners as set out in sections 3.2 to 3.4 below. We will not ask you to click a link or pay a fee to claim a prize – please report any accounts that may be impersonating us. If you have not won, you will not be notified.
- 3.2 The Wellbeing Escape prize is comprised of one Secret Escapes gift card valued at £5,000. Aviva will email the Secret Escapes gift card to the winner as an e-voucher within five working days of them claiming the prize. The Secret Escape gift card will be valid for one year from the date it is issued and cannot be extended. To redeem the gift card, the winner must create a Secret Escapes account and add the gift card to their account. Aviva has no responsibility other than providing the Secret Escapes gift card to the winner. If you win the Wellbeing Escape prize, you are responsible for making all arrangements for your holiday, including arranging all travel precautions that are reasonably required based on the destination you choose, for example appropriate travel insurance, immunisations and obtaining any visas needed. - 3.3 There are 10 x £100 Amazon gift cards available to win in the Prize Draw. Aviva will email the Amazon gift card details to the winners within five working days of them claiming the prize. Amazon gift cards must be redeemed within 12 months of receipt of the email. Amazon gift cards are subject to Amazon's [terms and conditions and privacy policy](#).
- 3.4 There are 20 x 12-month subscriptions to The Body Coach App available to win in the Prize Draw. Aviva will email the winners within five working days of them claiming the prize with details of the prize, including a code that can be used to activate the 12-month free subscription. 12 months after activation of the code, it will expire and winners will be responsible for their own subscription to The Body Coach App. The Body Coach App's [terms and conditions](#) and [privacy policy](#) apply to the subscription and your use of the app.

4 Use of Personal Information and the Names of Winners

- 4.1 Any personal data provided by you to enter this Prize Draw will only be used to administer it in accordance with these terms and conditions, to notify you if you are one of the winners and as otherwise set out in our Privacy Policy. We may share winners' personal data with third parties in order to provide and administer the Prizes.
- 4.2 We may publish or make available on request the surname and county of the main prize winner in accordance with Advertising Standards Authority CAP Code. If you are the winner of the Wellbeing Escape prize and do not want your personal data made available in this way or for it to be limited, please let us know us at the time you are informed you are the winner.

You acknowledge that Aviva does not control and shall not be liable in respect of these third parties use of your personal data when taking up / using your prize.

5 The Promotor

- 5.1 The promoter of this Prize Draw is Aviva Insurance Limited a company incorporated in Scotland with registered number SC002116 and whose registered office is at Pitheavlis, Perth PH2 0NH, United Kingdom (“**Aviva**”, “**we**”, “**us**” or “**our**”).
- 5.2 This Prize Draw is **not** sponsored, endorsed or administered by, or associated with Secret Escapes or Amazon. We have partnered with Strava to host the #MovewithAviva Challenge, however Strava does not otherwise administer the Prize Draw.

6 General

- 6.1 Aviva will not be liable to compensate you if: your prize is lost, stolen, unused, destroyed or used without permission, unless caused by Aviva's negligence.
- 6.2 While nothing in these terms and conditions will limit Aviva's liability for death or personal injury caused by its negligence or for fraud, or any other liability which cannot be lawfully excluded or limited, Aviva shall not be liable for:
- any failure to comply with its obligations where the failure is caused by something outside its reasonable control; or
 - for any losses that you may incur which were not foreseeable by Aviva or you at the time of your participation in the Prize Draw.
- 6.3 If there is any reason to believe that there has been a breach of these terms and conditions, we may, at our sole discretion, reserve the right to exclude you from participating in the Prize Draw.
- 6.4 If any paragraph in these terms and conditions is found by any court or administrative body of competent jurisdiction to be invalid or unenforceable, such invalidity or unenforceability shall not affect the other paragraphs of these terms and conditions, which shall remain in full force and effect.
- 6.5 These terms and conditions are subject to the laws of England and Wales and disputes will be subject to the non-exclusive jurisdiction of the English courts.
