

Aviva Life Insurance Plan Amazon.co.uk Gift Card Promotion Terms and Conditions

- These terms and conditions apply to the Aviva Life Insurance Plan Amazon.co.uk Gift Card promotion (the "Promotion"). By claiming the Amazon.co.uk Gift Card in connection with this Promotion, you are accepting these terms and conditions. Accordingly, please read carefully before deciding whether to redeem your Amazon.co.uk Gift Card.
- 2 This Promotion is brought to you by Aviva UK Digital Limited, a company registered in England and Wales (company number 09766150) and having its registered office at 8 Surrey Street, Norwich, Norfolk, NR1 3NG and being authorised and regulated by the Financial Conduct Authority with Firm Reference Number 728985 ("the Promoter", "we", "us"). Aviva UK Digital Limited sells life insurance and critical illness policies provided by Aviva Life & Pensions UK Limited, a company registered in England and Wales (company number 3253947) with its registered office at Aviva, Wellington Row, York, YO90 1WR, and being authorised by the Prudential Regulation Authority and regulated by the Financial Conduct Authority and the Prudential Regulation Authority with Firm Reference Number 185896 ("Aviva"). Fulfilment of the Promotion will be managed by our third party supplier, Hawk Incentives Limited, 1 Westside, London Road, Hemel Hempstead, Hertfordshire, HP3 9TD.

You will not be eligible to benefit from this Promotion if, within the last 12 months you have cancelled a Life Insurance Plan purchased directly from Aviva. Neither Aviva staff nor its contractors are eligible to benefit from this Promotion.

The Promoter reserves the right to end or modify the Promotion at any time, for any reason and without prior notice or explanation, but will always endeavour to minimise the effect to participants in order to avoid undue disappointment. - 6 You will receive an email with details of your Amazon.co.uk Gift Card within 28 days of receipt by Aviva of your 6th monthly premium for your Aviva Life Insurance Plan. Gift Cards must then be claimed within 30 days of receipt of the email, and must be redeemed within 10 years of receipt. Please note that the Gift Cards are provided electronically, as e-gift cards, and not as physical gift cards. Only one Amazon.co.uk Gift Card will be distributed per Aviva Life Insurance Plan sold (including Joint Plans), limited to two Amazon.co.uk Gift Cards per address.
