We are writing to inform you of proposed changes to our business operations.

You currently receive an annuity pursuant to a policy that is currently provided by Aviva Life & Pensions Ireland DAC (**ALPI**), an Irish insurance company regulated by the Central Bank of Ireland (**CBI**).

Your policy is currently managed on behalf of ALPI by Athora Belgium NV/SA (**Athora Belgium**), a Belgian insurance company regulated by the National Bank of Belgium.

We are proposing to transfer a number of policies from ALPI to Athora Belgium. Your policy is included in this proposed transfer (**Transfer**).

Athora Belgium already manages your policy on ALPI's behalf, so this change will not affect how your policy works. The proposed Transfer is part of a wider business update at ALPI.

As ALPI is an Irish registered company, the Irish High Court must approve the Transfer. If approved, your policy provider is expected to change from ALPI to Athora Belgium in 2026. Athora Belgium will become the data controller of your personal data from that

What this means for you

Your policy will continue to operate as it does today.

The terms, value, and servicing of your policy will remain unchanged and you will see no difference in the way your policy works as a result of the Transfer. If you have a loan on your policy, it will not be affected. You will continue to use the usual contact details which can be found on your policy documentation if you need to make a claim or have a general question about your policy.

Your policy may also be covered by the Belgian Guarantee Fund for Financial Services.

Your policy is not currently covered by a policyholder protection fund in Ireland. If the Transfer takes place, you may also benefit from access to the Belgian Guarantee Fund for Financial Services which provides protection of up to EUR 100,000 per life insurance policyholder if a Belgian regulated life insurer becomes insolvent or if the National Bank of Belgium decides it can no longer meet its obligations.

An Independent Actuary has reviewed the transfer.

An Independent Actuary has concluded that the Transfer has no material adverse effect on:

- the security of benefits of any policyholders;
- the reasonable expectations of any policyholders with respect to their benefits; and
- the standards of administration, service, management and governance that will apply to any policyholders.

A summary of the Independent Actuary's report is included in the accompanying documents.

The transfer is subject to a legal and regulatory process.

To protect your interests, we are required to follow a formal legal and regulatory process before the Transfer can go ahead. You will find more details about this process in the enclosed Frequently Asked Questions (FAQ) document provided in this Communication Pack.

What you need to do

We suggest that you read and then keep the documents in this Communication Pack in a safe place.

You do not need to take any action unless you object to or believe you may be adversely affected by this proposed Transfer. If you have questions or objections, or believe you may be impacted negatively, you can contact us by phone, email, post or submit your views online.

Details on how to do this are included in the accompanying documents and on our Transfer website. If you are a trustee or co-policyholder (or if someone else is

associated with your policy), please inform all interested parties of these proposals and their right to object.

If you received more than one Communications Pack, we have circulated one for each policy that you hold.
